- ✓ **Associate Member Dues - \$25.00 annually. Persons who have not matriculated from SAU. Not eligible to hold office.**

 - ✓ **Life Membership Gold Cards will be mailed within 30 days with a Life Member pin. New Life Memberships beginning this year.**

- ✓ **We are in the process of changing to an electronic System to automatically send cards when dues are paid online for General and subscribing Life memberships. Life Membership cards will still be mailed with the pin.**

- **Membership Dues paid through Alumni Chapters**
 - ✓ **When paying NAA Dues through your Alumni Chapter it is your responsibility to make sure all contact information is sent to NAA with the payments.**
